

SOUTHWARK SCHOOLS SMART SAVERS COMPETITION

TERMS AND CONDITIONS

1. THE PROMOTER

- 1.1 The promoter is the Mayor and Burgesses of the London Borough of Southwark, whose principal address is at 160 Tooley Street, London SE1 2QH.

2. THE COMPETITION

- 2.1 The title of the competition is School Prize for Southwark Smart Savers.
- 2.2 The prize will go to the eligible school which has the highest number of applicants (in percentage terms) of children redeeming their smart savers vouchers at the London Mutuals Credit Union.

3. HOW TO ENTER

- 3.1 The competition will run from 9th October 2017 (the "**Opening Date**") to 1st September 2018 (the "**Closing Date**") inclusive.
- 3.2 Eligible schools will automatically qualify for entry.

4. ELIGIBILITY

- 4.1 The competition is only open to state funded primary schools based within the Southwark boundary.
- 4.2 The schools must have at least two Eligible Children. Eligible Children are defined as children who are in year 6 and are attending Southwark based state funded primary school and have successfully claimed a £20 (twenty pound) voucher to deposit into a new or existing London Mutual Credit Union junior saver account.
- 4.3 The child's application must be received by the London Mutual Credit Union before the Closing Date.
- 4.4 The Promoter reserves all rights to disqualify any school whose conduct is contrary to the spirit or intention of the prize competition.

5. THE PRIZE AND THE WINNER

- 5.1 The winner will have the choice of requesting books or IT equipment to the value of £2,000.00 (two thousand pounds) which will be agreed with and ordered by the Promoter.
- 5.2 The school with the highest number of Eligible Children will be winner. However, in the event of a tie break, the value of the prize described above in clause 5.1 will be shared equally between the winners.
- 5.3 There is no cash alternative for the prize.

6. WINNER ANNOUNCEMENT

- 6.1 The winner of the competition will be the school with the highest number of applicants (as a percentage) and will be announced on www.southwark.gov.uk/smartsavers by 31st October 2018.
- 6.2 The decision of the Promoter is final and no correspondence or discussion will be entered into.
- 6.3 The promoter will contact the head teacher of the winning by email or telephone after the Announcement Date.

7. CLAIMING THE PRIZE

- 7.1 If you are the winner of the prize, you will have until 31st December 2018 to claim the prize. In order to claim the prize you must contact the Promoter by email. If you do not claim the prize by this date, your claim will become invalid.
- 7.2 The Promoter will make all reasonable efforts to contact the winner. If the winner cannot be contacted or is not available, or has not claimed their prize by 31st December 2018, then the winner's prize will be forfeited and the Promoter will be entitled to offer the prize to the next eligible school.
- 7.3 The Promoter does not accept any responsibility if the winner is not able to take up the prize.
- 7.4 Insofar as is permitted by law, the promotion, will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of the Promoter, its agents or distributors or that of their employees.

8. PUBLICITY AND DATA PROTECTION

- 8.1 The winner may be required to participate in publicity related to the competition which may include the publication of their school's name and photograph in any media.
- 8.2 Personal data supplied during the course of this competition may be passed on to third party suppliers only insofar as required for fulfilment/delivery of the prize.

9. GENERAL

- 9.1 Participants are deemed to have accepted and agreed to be bound by these terms and conditions. If there is any reason to believe that there has been a breach of these terms and conditions, the Promoter may, at its sole discretion, reserve the right to exclude the school from participating in the competition.

- 9.2 The Promoter reserves the right to hold void, suspend, cancel, or amend the prize competition where it becomes necessary to do so.
- 9.3 These terms and conditions shall be governed by English law, and the parties submit to the non-exclusive jurisdiction of the courts of England and Wales.
