- 1. Southwark Council hereby GIVES NOTICE that it proposes to make the above orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.
- 2. The effect of the (Charged-for parking places) Order would be in LIVERPOOL GROVE within Controlled Parking Zone 'M2', to:-
- (a) remove a total of 109.5m 'shared-use' parking places, on both sides (north-east of its junction with Walworth Road) and north-east side o/s St Peter's Church; and
- (b) install 7 permit-holders' only parking places north-east side o/s St Peter's Church standing at an angle of 90° to the kerb (4.5m in length and 2m in width).
- 3. The effect of the (Free parking places, Loading places and Waiting, Loading and Stopping restrictions) Order would be in LIVERPOOL GROVE, to:-
- (a) remove 2 unlimited stay Disabled Persons parking places (DPPPs) south-east side on the side of No. 347 Walworth Road and 1 unlimited stay DPPP north-east side o/s St Peter's Church, and (ii) install 2 unlimited stay DPPPs (which may be used without time limit by vehicles displaying a valid disabled persons 'blue badge') north-east side o/s St Peter's Church standing at an angle of 90° to the kerb (4.8m in length and 3.6m in width);
- (b) install 6m loading bay north-west side on the side of No. 345 Walworth Road which may be used 'at any time' for the purpose of loading only and for 'permitted vehicles' only (max stay 1 hr, no return within 2 hrs);
- (c) add 25m new 'at any time' loading restrictions (double kerb blips), south-west side opposite St Peter's Church;
- (d) add a total of 95.5m of timed waiting restrictions (single yellow lines), on both sides (north-east of its junction with Walworth Road) operating Mon to Fri 8:30 am 6:30 pm; and
- (e) amend existing lengths of 'at any time' waiting restrictions north-east side o/s St Peter's Church to accommodate changes to the parking in that location.
- 4. The effect of the (Prescribed routes) Traffic Order would be to:-
- (a) revoke and remove an existing fire gate and existing pedal cycle gaps in LIVERPOOL GROVE, and the vehicle prohibitions associated with those features; and
- (b) provide a 'no motor vehicles' restriction in that part of LIVERPOOL GROVE which lies between its junction with Walworth Road and a point 66m north-east of that junction, (i) exemptions provided for emergency services vehicles at both points of the part road closure, and (ii) further exemptions provided for vehicles travelling in a north-westerly or south-westerly direction in Liverpool Grove which are 'permitted vehicles' as recognised by the Council (the vehicle registration number thereof being registered with and authorised by the Council for this purpose, such authorisation being granted by the Council on a discretionary basis and subject to such criteria as may be set by the Council), vehicles used for road maintenance or cleansing purposes, and refuse collection.

The London Borough of Southwark (Prescribed routes) (Liverpool Grove) Traffic Order 202*

The Council proposes to make permanent changes to create a new public realm space to prohibit motor vehicle movements at the western section of Liverpool Grove within the Faraday ward and the North Walworth ward, in the London Borough of Southwark.

The aims of the scheme are to create a new public realm space which will:-

- Make Liverpool Grove a more pleasant and attractive place to enjoy
- Make Liverpool Grove a cleaner, greener and safer environment
- Enhance the view of St Peter's Church, a grade listed building
- Make cycling and walking safer and more enjoyable
- Support local businesses by creating more space for the local economy
- Create a space that will benefit local residents

The above aims and key objectives of the scheme will deliver against the missions set out in Southwark's Movement Plan and helps to improve the wider Walworth area.

A summary of the proposed changes are as follows, in Liverpool Grove:

existing fire gate and pedal cycle gaps removed all vehicle prohibitions associated with those features will be revoked.

'at any time' motor vehicle restriction introduced in Liverpool Grove between its junction with Walworth Road and a point 66 metres north-east of that junction.

Exemption to the restrictions described in the preceding would be provided (i) for emergency services vehicles at both points of the part road closure, and (ii) for vehicles travelling in a north-westerly or south-westerly direction in Liverpool Grove which are 'permitted vehicles' as recognised by the Council (the vehicle registration number thereof being registered with and authorised by the Council for this purpose, such authorisation being granted by the Council on a discretionary basis and subject to such criteria as may be set by the Council), vehicles used for road maintenance or cleansing purposes, and refuse collection.

amend parking - remove a total of 109.5 metres of 'shared-use' parking places; install 7 permit-holders' only parking places north-east side o/s St Peter's Church standing at an angle of 90° to the kerb; remove 2 unlimited stay Disabled Persons parking places (DPPPs) and 1 unlimited stay DPPP, and install 2 unlimited stay DPPPs north-east side o/s St Peter's Church standing at an angle of 90° to the kerb; install new loading bay north-west side on the side of No. 345 Walworth Road which may be used 'at any time' for the purpose of loading only and for 'permitted vehicles' only (max stay 1 hr, no return within 2 hrs).

new 'at any time' loading restrictions (double kerb blips) added south-west side opposite St Peter's Church.

new timed waiting restrictions (single yellow lines) added on both sides (north-east of its junction with Walworth Road) operating Mon to Fri 8:30 am - 6:30 pm to accommodate changes to the parking.

existing 'at any time' waiting restrictions (double yellow lines) amended to accommodate changes to the parking.

- 4.3 The provisions of the Order of 2021 (other than Articles 4 and 19) shall apply to the area designated as a parking place by this Order as if in those provisions any reference to a parking place included a reference to an area designated as a parking place by this Order.

Placing of traffic signs, etc

 - (b) place and maintain in or in the vicinity of each parking place, traffic signs indicating that such parking place may be used during the permitted hours for the leaving only of the vehicles specified in Articles 5.1 and 5.2 of the Order of 2021; and

Prescribed routes

- 3.1 No person causing any motor vehicle to proceed in Liverpool Grove shall cause that motor vehicle to enter into that part of Liverpool Grove which lies between its junction with Walworth Road and a point 66 metres north-east of that junction with the exception of 'permitted vehicles' travelling in a north-westerly or south-westerly direction in Liverpool Grove.
- 3.2 No person causing any motor vehicle to proceed in Walworth Road shall cause that motor vehicle to enter into that part of Liverpool Grove which lies between its junction with Walworth Road and a point 66 metres north-east of that junction.

Exemptions

- 4.1 Nothing in Articles 3.1 or 3.2 of this Order shall apply in relation to:-
 - (a) anything done with the permission or at the direction of a police constable in uniform;
 - (b) any vehicle being used for ambulance, fire brigade or police purposes; or
 - (c) any person who causes any vehicle to proceed in accordance with any restriction or requirement indicated by traffic signs placed on the highway pursuant to section 66 or section 67 of the Road Traffic Regulation Act 1984.
- 4.2 Nothing in Article 3.1 of this Order shall apply in relation to:-
 - (a) any vehicle being used for the purpose of maintenance, improvement, re-construction, cleansing or lighting of that part of street;
 - (b) any vehicle being used in connection with the laying, erection, alteration, or repair in or adjacent to that part of street of any sewer, main, pipe or apparatus for the supply of gas, water, electricity, or of any electronic communications network; or the placing, maintenance or removal of any traffic sign, if the vehicle cannot be used for that purpose in any other street or part of street;
 - (c) a refuse collection vehicle being operated by the Council or its appointed contractor, whilst being used for the purpose of refuse collection at premises located within a prescribed street; or
 - (d) a vehicle, recognised by the Council as a being a "permitted vehicle", the vehicle registration number thereof being registered with and authorised by the Council for this purpose by or on the behalf of the vehicle registration number thereof, such authorisation being granted by the Council on a discretionary basis and subject to such criteria as may be set from time to time by the Council.

Revocations
