

# Tustin Estate newsletter

## November 2019

Welcome to the latest edition of the Tustin Estate monthly newsletter from Southwark Council, regarding the future of the low rise homes and the public places on the Tustin Estate.

Between now and the Summer of 2020, residents of the blocks and houses, the school and the businesses on the estate will be engaged with as part of the consultation on options ranging from doing nothing, refurbishing the blocks and houses, infilling with a new block, extending the blocks, or knocking some or all of the blocks and houses down and replacing them with new homes.

The first hour will be a public meeting for the architects to present the emerging ideas for the initial options and priorities that have been drawn up followed by a chance to look at the display boards and speak to the architects from Common Grounds on the content.

#### New architects on board

Thank you so much to those of you who came and met Common Grounds at the drop in session last month. As a reminder Common Grounds is a collective led by architects DSDHA, including Kennedy Woods, Hayhurst & Co, and Resolve.

Common Grounds will work with residents from now until around spring to draw up options for the low rise homes and the open space on the estate.

Common Grounds has taken on board your feedback from the drop-in session and wider conversations with officers about what you like and don't like about your homes, block and estate. The architects will be presenting the emerging ideas for the initial options at a public meeting on Thursday 26 November 2019. If you can't come along, do not worry, as there are other opportunities to get involved. On Thursday 28 November 2019 between 2pm and 5.30pm at 801 Old Kent Road (under Bowness House) there will be a drop-in session to meet the team from Common Grounds to go through the emerging ideas.

If you want to contact Common Grounds, they can be contacted at **commongrounds@dsdha.co.uk**. They will shortly be setting up a base on the estate at 801 Old Kent Road (under Bowness House). Starting on Thursday 14 November 2019 you can speak to them face to face on a one to one basis, every Thursday between 2pm and 5.30pm.

As the options are developed there will be plenty of opportunities for everyone to get involved. This will be through more drop-in events with Common Grounds, to comment on the options and feedback on what you like and don't like and make alternative suggestions.

#### **Stock Condition Survey**

Hunters have been appointed by Southwark Council to survey the low rise homes on the estate to assess their condition and let us know how much it will cost to maintain each block over the next 30 years.



They will need to get in to 30% of the tenanted homes and will be inspecting all the communal areas. All their staff will be carrying Identification and if they

need to get in to your home, they will write to you first.

#### **One to One Visits**

Southwark Council officers are visiting all the low-rise homes on the Tustin Estate. Our aim is to visit every home on an appointment basis; but where no contact has been made through email or the telephone, a home visit will be carried out.
