The London Borough of Southwark (Charged-for parking places) (Dockley Road area) Order 202* The London Borough of Southwark (Waiting restrictions) (Dockley Road area) Order 202*

- 1. Southwark Council hereby GIVES NOTICE that it proposes to make the above Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.
- The effects of the Orders would be:-
- (a) within Controlled Parking Zone 'TS' (i) in DOCKLEY ROAD to remove an existing 'shared-use' parking place (16.5 metres in length) on the south-east side o/s Nos. 1 and 2 Eldridge Court, Rouel Road, and to formally extend an existing shared-use' parking place by 6 metres o/s No. 3 Eldridge Court, Rouel Road (this parking place will remain unchanged in the street, at a total of 39 metres in length, this is an administrative change to more accurately reflect in the Traffic Order covering this restriction and what is in the street), and (ii) in ROUEL ROAD to add two new 'shared-use' parking places (each bay is 18 metres in length) on the north-east side between its junctions with Dockley Road and Spa Road;
- (b) within Controlled Parking Zone 'GR' (i) in SPA ROAD to remove an existing 'shared-use' parking place (19.5 metres in length) on the south-east side o/s No. 138 Spa Road, and to add a new 'shared-use' parking place (5.5 metres in length) on the south-east side o/s No. 138 Spa Road, and (ii) to relocate an existing car club parking place in ENID STREET on the south-west side (north-west of its junction with Rouel Road) south-eastward by 6 metres and increase the length of an existing 'shared-use' parking place by 6 metres to accommodate; and
- (c) to add new or amend existing 'at any time' waiting restrictions (double yellow lines) to accommodate the above-mentioned parking changes in DOCKLEY ROAD, SPA ROAD and ROUEL ROAD, and convert 3 metres of existing 'timed' waiting restrictions (single yellow lines) to 'at any time' waiting restrictions in SPA ROAD on the south-east side, north-east of the northeastern wall of No. 138 Spa Road.
- 3. Southwark Council hereby GIVES FURTHER NOTICE under sections 90A to 90I of the Highways Act 1980 and in accordance with the provisions of the Highways (Road humps) Regulations 1999 and the Highways (Traffic calming) Regulations 1999, it proposes to:
- (a) construct a speed table of flat-top construction having a maximum height of 100 millimetres and covering the entire width of the carriageway, in DOCKLEY ROAD extending from the northeastern wall of No. 1 Eldridge Court, Rouel Road north-eastward for a distance of 6.5 metres, including both ramps; and
- (b) relocate and replace an existing road hump of sinusoidal cross-section construction, approx. 3.7 metres in length, having a maximum height of 100 millimetres and covering the greater width of the carriageway in SPA ROAD, centred at a point 9 metres north-east of the north-eastern kerbline of Rouel Road.
 - Notes: (1) All measurements are in metres and are approximate. (2) 'shared-use' refers to parking places in which holders of a valid permit for the Controlled Parking Zone listed, or 'pay' paid ticket holders are permitted to park within the hours of operation for that Zone. Statement of reasons

Dockley Road area improvements



The London Borough of Southwark (Charged-for parking places) (Dockley Road area) Order 202* The London Borough of Southwark (Waiting restrictions) (Dockley Road area) Order 202*

The scheme proposes changes to parking and waiting restrictions, and new traffic calming measures in the Dockley Road area, within the South Bermondsey ward, in the London Borough of Southwark. These changes are implemented as part of the redevelopment of Dockley Road Industrial Estate.

The planning permission (ref: 18/AP/0091) granted for this development includes the provision of vehicle access from Spa Road to the new development (an existing road hump in Spa Road will be relocated to accommodate this); and a new raised speed table in Dockley Road, which will improve existing traffic calming measures and provide ease of pedestrian crossing.

A total of approximately 36 metres of existing 'shared-use' parking places will be removed in Spa Road within Controlled Parking Zone (CPZ) 'GR' and in Dockley Road within CPZ 'TS'. A total of approximately 47.5 metres of additional 'shared-use' parking will be introduced in Enid Street and in Spa Road within CPZ 'GR', and in Rouel Road within CPZ 'TS', to compensate for the loss of parking mentioned above. An existing car club parking place in Enid Street (south-west side) will be relocated south-eastward by 6 metres.

Add new or amend existing 'at any time' waiting restrictions (double yellow lines) to accommodate the parking changes in Dockley Road, Spa Road, and Rouel Road; and convert timed waiting restrictions (single yellow lines) to 'at any time' waiting restrictions (double yellow lines) in Spa Road.

Southwark Council will also take this opportunity to formally extend, by 6 metres, an existing 'shared-use' parking place on the south-east side of Dockley Road (north-east of its junction with Rouel Road). There will be no physical changes to this parking place in the street, this will be an administrative change to more accurately reflect in the Traffic Order covering this restriction with what is in the street.

The Council of the London Borough of Southwark, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984^a, as amended, and of all other powers thereunto enabling, hereby make the following Order:

Citation and commencement

1.1 This Order may be cited as the London Borough of Southwark (Charged-for parking places) (Dockley Road area) Order 202* and shall come into force on 202*.

Interpretation

2.1 In this Order:-

"Council" means the Council of the London Borough of Southwark;

"enactment" means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment;

"map-based schedule" means the map attached to and to be read in conjunction with this Order and the Order of 2021, which depicts the parking places designated by this Order, and, in conjunction with the map schedule legend, identifies the type of each particular parking place and, if appropriate, certain of its governing provisions:

Provided that the Council does not accept responsibility for any inaccuracies contained in the Ordnance Survey data relied upon to create the map-based schedule and where a parking place is depicted on the map-based schedule, that parking place will continue to apply irrespective of any subsequent changes that have been made to the underlying Ordnance Survey data.

"map schedule legend" means the map schedule legend attached to this Order which, when used in conjunction with the map-based schedule, identifies the specific type of parking place designated by this Order and, where appropriate, certain of its governing provisions;

"the Order of 2021" means the London Borough of Southwark (Charged-For Parking Places) (Map-based) Order 2021^b; and

"traffic sign" means a sign of any size, type and colour prescribed or authorised under, or having effect as though prescribed or authorised under, section 64 of the Road Traffic Regulation Act 1984

- 2.2 Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- 2.3 Unless the context otherwise requires, any expression used in this Order which is also used in the Order of 2021 shall have the same meaning as in that Order.

Amendment of items in the map-based schedule

- 3.1 Without prejudice to the validity of anything done, or to any liability incurred in respect of any act or omission before the coming into force of this Order, the Order of 2021 shall have effect as though:-
 - (a) where there is no existing item at a location depicted in the map-based schedule attached to that Order, there were added to that map-based schedule the item depicted in the map-based schedule attached to this Order; and
 - (b) where there is an existing item at a location depicted in the map-based schedule attached to that Order, there were substituted in that map-based schedule the item depicted in the map-based schedule attached to this Order.
- 3.2 The amendment referred to in Article 3.1 of this Order of an item in the map-based schedule will have the effect of revoking any provision provided or designated by a previous version of that item in the map-based schedule and not incorporated into the latest version.

Designation of parking place and application of the Order of 2021 thereto

- 4.1 Each area on a street identified the map-based schedule as a parking place and, where applicable, by way of the map schedule legend as an area marked out and signed for the use therein of specified classes of vehicles following the conditions specified in the Order of 2021 in relation to that type of parking place, is designated as a parking place.
- 4.2 Unless otherwise so identified, a parking place shall be bounded on one side of its length by the edge of the carriageway and be an area marked either by a traffic sign or by another method of indicating the extent of a parking place as specified in the Traffic Signs Regulations and General Directions 2016°.
- 4.3 The provisions of the Order of 2021 (other than Articles 4 and 19) shall apply to the area designated as a parking place by this Order as if in those provisions any reference to a parking place included a reference to an area designated as a parking place by this Order.

Placing of traffic signs, etc

- 5.1 The Council shall:
 - (a) place and maintain traffic signs or other appropriate markings on the surface of the street indicating the limits of the parking places designated by this Order;

- (b) place and maintain in or in the vicinity of each parking place, traffic signs indicating that such parking place may be used during the permitted hours for the leaving only of the vehicles specified in Articles 5.1, 5.3 and 5.9 of the Order of 2021; and
- (c) place and maintain in or in the vicinity of each pay parking place a traffic sign indicating that such parking place may be used by vehicles making payment of the parking charge by way of the electronic payment system; and the location identification number of such parking place or part thereof; and
- (d) carry out such other work as is reasonably required for the purpose of the satisfactory operation of a parking place.
