## **Electric scooter trial**



The London Borough of Southwark (Various provisions and exemptions) (e-scooter trial) (No. 2) Experimental Traffic Order 2023

- 1. Southwark Council hereby GIVES NOTICE that on 20 April 2023 it has made the above experimental order under sections 9 and 10 of the Road Traffic Regulation Act 1984, as amended.
- 2. The general effect of the Experimental Order will be, in connection with electric scooters (henceforth referred to as 'e-scooters') being used in a trial, to:-
  - (a) re-designate certain cycle tracks made pursuant to section 65 of the Highways Act 1980 as restricted carriageways; and
  - (b) to exempt e-scooters, being used in a trial, from cycle lanes installed prior to when the Traffic Signs Regulations and General Directions 2016 came into force.
  - Note: Transport for London will permit the use of e-scooters on all GLA roads and side roads, where pedal cycles can already proceed, within the London Borough of Southwark from 7 June 2021. Details of Transport for London's Order can be found by visiting their website.
- 3. Southwark Council hereby GIVES FURTHER NOTICE that under Section 15(4) of the Greater London Council (General Powers) Act 1974, have resolved that vehicles (being e-scooters used in a trial, and in some cases pedal cycles for hire) which are parked on the footway and wholly within the areas delineated by white lines, on the footway at the locations identified below, shall be exempt from Section 15(1) of the said Act which makes it an offence to park on the footway. The resolution shall take effect from 27 April 2023. E-scooter and cycle hire parking places designated at the following locations:-

The council will in due course be considering whether the provisions of the experimental order should be continued in force indefinitely, by means of a permanent order made under the powers of the Road Traffic Regulation Act 1984. Anyone wishing to object to the making of the permanent order or make any other representation regarding the scheme would have 6 months to do so, from the date the experimental order comes into force (or, if the order is varied by a subsequent order or modified pursuant to section 10(2) of the Road Traffic Regulation Act 1984, from the date that variation order or modification comes into force), and may send a statement to <a href="mailto:traffic.orders@southwark.gov.uk">traffic.orders@southwark.gov.uk</a> or to: Traffic Order consultations, Highways, Southwark Council, Environment, Neighbourhoods and Growth, P.O. Please note that if you wish to object to the scheme you must state the grounds on which your objection is made.
- 7. Under requirements of current access to information legislation, any letter or e-mail sent to the Council in response to this Notice may be subject to publication or disclosure, or both, including communication to other persons affected.
- 8. Anyone wishing to question the validity of the order or of any provision therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made thereunder have not been complied with in relation to the order may, within 6 weeks of the date on which the order was made, make application for the purpose to the High Court.

# Statement of reasons

# Electric scooter trial



The London Borough of Southwark (Various provisions and exemptions) (e-scooter trial) (No. 2) Experimental Traffic Order 2023

The decision has been made for the London Borough of Southwark to continue the pan-London electric scooter (e-scooter) trial.

For the purpose of the scheme, the Department for Transport (DfT) have made an interim provision that legalises the use of the appointed companies' e-scooters and categorises them as motor-vehicles: <u>The Electric Scooter Trials and Traffic Signs (Coronavirus) Regulations and General Directions 2020</u> (as amended).

Due to the need to adopt a multi-borough approach to a trial in London, it has been agreed that Transport for London (TfL) would act as the lead authority. It is illegal to use privately-owned escooters on public property including roads, pavements and cycle lanes. However, for the purpose of the trial, the three appointed companies (Dott, Tier and Lime) have been selected and given the opportunity of running hire schemes whereby e-scooters can be used. The use/hire of private e-scooters and non-participating e-scooters companies will remain illegal and subject to enforcement by the Police.

The above-mentioned Order will, by way of an experiment, permit e-scooters being used in the trial to:

- proceed on any cycle track (both shared-use and segregated); and
- proceed in any cycle lane;

within the London Borough of Southwark for the duration of the e-scooter pan-London trials.

The reason for introducing this Order experimentally is to enable the London Borough of Southwark to facilitate the riding of e-scooters provided as a part of the trial hire scheme and, as a consequence, to understand whether and how these vehicles can be safely accommodated in London in the manner established by Government Regulations for the purposes of trials.

Further to the Experimental Order, Southwark Council has, by resolution under Section 15(4) of the Greater London Council (General Powers) Act 1974, informed that vehicles (being e-scooters used in a trial, and in some cases pedal cycles for hire) which are parked on the footway and wholly within the areas delineated by white lines, on the footway at the locations identified below, shall be exempt from Section 15(1) of the said Act which makes it an offence to park on the footway. The resolution shall take effect from 27 April 2023. E-scooter (and in some cases e-scooter and pedal cycles for hire) parking places will be designated at 19 different locations across the London Borough of Southwark, as marked bays on the footway.

These measures are subject to experimental Traffic Management Orders (TMOs). A TMO is the legal mechanism the council, as traffic authority, uses to control aspects of the way that the highway is used. They provide the legal backing to signs and road markings used on the highway and allow them to be enforceable.

The experimental TMO will be enforceable for a period up to 18 months to allow the assessment of any impact the restrictions might have on the area and surrounding roads, and to revise the scheme if necessary within that time. A review will be carried out to assess the initial success of the scheme and whether the restrictions should be made permanent.

The Council of the London Borough of Southwark, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 9 and 10 of the Road Traffic Regulation Act 1984<sup>a</sup>, as amended, and of all other powers thereunto enabling, hereby make the following Order:

#### Citation, commencement and expiry

1.1 This Order may be cited as the London Borough of Southwark (Various provisions and exemptions) (e-scooter trial) (No. 2) Experimental Traffic Order 2023, shall come into force on 27 April 2023, and will expire on 5 November 2024.

#### Interpretation

2.1 In this Order:-

causing includes permitting;

a reference to an Article or a Schedule followed by a number is a reference to the Article of, or Schedule to, this Order so numbered;

"carriageway", "cycle track" and "footway" have the same meaning as in section 329(1) of the Highways Act 1980<sup>b</sup> as amended;

"council" means the council of the London Borough of Southwark;

"enactment" means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment;

"cycle lane", "electric scooter", "pedal cycle" and "trial" have the same meaning as in the Traffic Signs Regulations and General Directions 2016°, as amended; and

"vehicle" includes part of a vehicle.

2.2 Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.

#### Controls

- 3.1 The cycle tracks listed in Schedule 1 of this Order (made pursuant to section 65 of the Highways Act 1980) are re-designated as restricted carriageway where electric scooters being used in a trial and pedal cycles only have right of way.
- 3.2 The shared-use areas listed in Schedule 2 of this Order (made pursuant to section 65 of the Highways Act 1980) are re-designated as areas of restricted carriageway where electric scooters being used in a trial, pedestrians and pedal cycles only have equal right of way.
- 3.3 The traffic Orders listed in Schedule 3 of this Order (stating which areas of carriageway are cycle lanes) shall include the following words "an electric scooter being used in a trial (within the meaning set out in Schedule 1 of the Traffic Signs Regulations and General Directions 2016, as amended) or" after every instance in which the words:-
  - (a) "No person shall cause any vehicle other than" appear in any Article within; and
  - (b) "Every person causing" appear in any Article within.

#### Exemptions

- 4.1 The controls specified in Article 3 to this Order do not apply in respect of a vehicle being in the restricted carriageway described in that Article if the vehicle is being used:-
  - (a) in connection with the removal of any obstruction to traffic;
  - (b) in connection with the maintenance, improvement or reconstruction of any road;
  - (c) in connection with the maintenance, improvement or reconstruction of any street furniture including bus stop infrastructure;
  - (d) in connection with the cleaning, removal of ice, snow or any impediment to traffic in any restricted carriageway; and
  - (e) in connection with the laying, erection, alteration or repair in or near the restricted carriageway of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunications apparatus as defined in paragraph 1(1) of Schedule 2 of the Telecommunications Act 1984<sup>d</sup>; if the vehicle cannot be used for that purpose without being in a restricted carriageway.
- 4.2 The controls specified in Article 3 to this Order do not apply to the restricted carriageway described in that Article in respect of:-
  - (a) a vehicle being used for fire brigade, ambulance or police purposes if the observance of the controls would hinder the use of the vehicle;
  - (b) a vehicle being used by a person or persons authorised by the London Borough of Southwark.

### Power to modify or suspend this Order

5.1 In pursuance of section 10(2) of the Road Traffic Regulation Act 1984, the Head of Service, Highways (or such other officer of the council as holds the post of Traffic Manager as defined in section 17 of the Traffic Management Act 2004°) may, if it appears to that officer essential in the interests of the expeditious, convenient and safe movement of traffic, or of the provision of suitable and adequate parking facilities on the highway, or for preserving or improving the amenities of the area through which any road affected by this Order runs, modify or suspend any provision of this Order, save that no modification shall make an addition.

#### Conditions and power to suspend restricted carriageways

6.1 The council may from time to time suspend the use of any section of restricted carriageway.

### Suspension of existing orders

- 7.1 While this Order remains in force, and without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into force of this Order:-
  - (a) the London Borough of Southwark (Various provisions and exemptions) (e-scooter trial) Experimental Traffic Order 2021 is suspended; and
  - (b) the Orders listed in Schedules 1 to 3 of this Order are each hereby suspended, in so far as their provisions relate to any length of road specified in the schedules to this Order.
