London Streetspace Programme – Southwark Bridge Road revocation

The London Borough of Southwark (Waiting and loading restrictions) (Amendment No. 114) Order 2020

1. Southwark Council hereby GIVES NOTICE that on 17 September 2020 it has made the above order under sections 6 and 124, and Part IV of Schedule 9, of the Road Traffic Regulation Act 1984¹, as amended.
2. The general effect of the order is to revoke the London Borough of Southwark (Waiting and loading restrictions) (Amendment No. 10) Experimental Traffic Order 2020², in entirety, pertaining to the London Streetspace Programme – Southwark Bridge Road area scheme (public notice originally advertised in *the London Gazette* on 16 July 2020³).
3. Copies of the order, which will come into force on 21 September 2020, and of all other relevant documents are available for inspection at Highways, Southwark Council, Environment and Leisure, 3rd floor hub 2, 160 Tooley Street, London SE1 2QH, by appointment only. 4. Any person desiring to question the validity of the order or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with in relation to the order may, within six weeks of the date on which the order were made, make application for the purpose to the High Court.

The London Borough of Southwark (Waiting and loading restrictions)
(Amendment No. 114) Order 2020

Made: 17 September 2020

Coming into force: 21 September 2020

The Council of the London Borough of Southwark, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984^a, as amended, and of all other powers thereunto enabling, hereby make the following Order:

Citation and commencement

- 1.1 This Order may be cited as the London Borough of Southwark (Waiting and loading restrictions) (Amendment No. 114) Order 2020 and shall come into force on 21 September 2020.

Interpretation

- 2.1 In this Order:-

"enactment" means any enactment, whether public general or local, and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment; and

"the Order of 2015" means the London Borough of Southwark (Waiting and loading restrictions) Consolidation Order 2015^b - as amended.

- 2.2 Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- 2.3 Unless the context otherwise requires, any expression used in this Order which is also used in the Order of 2015 shall have the same meaning as in that Order.

EXPLANATORY NOTE
