Summary

1. Introduction

Southwark Council manages three cemeteries, these are Nunhead Cemetery, Camberwell Old Cemetery and Camberwell New Cemetery. They all have historic buildings and memorials and are important places in local community life. Their histories are closely tied to the growth of the borough, and they also offer wider benefits for ecology, biodiversity and recreational activities.

Conservation Management Plans (CMPs) are an important guide for managers and they contain a review of the ecology, landscape and tree and woodland management for each cemetery. They highlight the value of the heritage and ecology, and include management policies and guidance, which aim to protect and enhance their value for the future, setting out aims and guidance for each cemetery for local community groups and residents. The CMPs can also be used to help apply for grants and funding to improve the cemeteries for visitors.

The council has produced draft CMPs for each of its cemeteries, to guide the management of these spaces. We are consulting with the public on these documents one at a time starting with the Nunhead Cemetery Conservation Management Plan (NCCMP).

2. The Survey

The consultation was open to the public from 5 June to 21 July 2023. An online survey was available on the council's Consultation Hub website. A paper copy of the CMP and survey was available upon request. A mailing list of 44 interested residents was informed when the public consultation began. Project staff attended the Nunhead Cemetery Open Day on the 20 May 2023, to raise awareness of the CMPs and the consultation.

A drop in event was held at The Green Community Centre, in Nunhead on Wednesday 28 June. We chose a location away from the cemetery to be as convenient and easy to access as possible for residents and to encourage participation from residents who may not visit the cemetery presently. The event was held from 3pm to 7pm to allow residents who may be available during the day as well as those who may be available after work the opportunity to attend.

A virtual consultation meeting was held on Tuesday 4 July from 6.30pm for residents who could not attend the in-person drop in meeting.

The consultation was also promoted through posters displayed in and around Nunhead Cemetery (see appendix 1).

Local community and faith groups were contacted, to provide them with the consultation details and posters to place up in their community centres and places of worship.

3. Executive Summary

The consultation received a total of eight responses, this is a low response rate, however each respondent returned a large number of comments, with a lot of great suggestions on how to improve the CMPs. Those comments and suggestions are reviewed in full from page 4.

There were a number of comments about the consultation itself and the documents being presented. Several respondents felt that they were too long, mistakenly thinking that the CMP was a consultation questionnaire. The length of the CMP cannot be reduced as every CMP must follow a standard format and structure. This is explained in more detail in the results section.

Residents also requested a shorter summary document, however we had to provide the whole document, to make sure all of the information was available to the public, before the CMP is finalised.

Regarding the information in the CMP the key feedback included;

Respondents mentioned that they like the view of St Pauls (Cathedral) and are pleased that it will be maintained, however they also mentioned that during the warmer months, fast growing vegetation can block the view, and during the spring and summer it would need more maintenance. Unfortunately, the regularity of maintenance is limited by our maintenance budget. Should visitors notice that the view has become obscured, it would be helpful if they could inform council staff on site or by emailing parks@southwark.gov.uk

Some respondents felt that some of the Victorian graves need more maintenance, and that the vegetation also required more regular maintenance, so that more people can access inner areas of the cemetery. The amount of maintenance that our team can carry out is limited by our maintenance budget. The CMP currently advises against cutting back vegetation to allow access to the inner areas of the cemetery. This is to protect the woodland environment and wildlife in these inner areas of the cemetery, and discourage visitors from treading new pathways that are not part of the historic path network that we wish to protect.

We had several comments about how burials are managed in the cemetery, both currently and in the future. It was suggested that some new burials could be allowed, if done sensitively. No new burials take place at Nunhead Cemetery, except for second interments, as the last two active burial areas became full in 2022. There are currently no plans for new burial areas to be created. The cemetery's important status as a nature reserve will be given consideration, should any plans for new burials be made in the future.

Some respondents stated that they were opposed to the re-use of graves, however there was also a comment saying that graves should be re-used, highlighting the different opinions about this matter. The re-use of graves is not currently being considered and would require agreement from the Council Cabinet if it were to be pursued in the future. Re-use has not been proposed or considered at Nunhead Cemetery and so references to re-use have been removed from the NCCMP.

There were several comments about dogs in the cemetery, about the current PSPO (Public Spaces Protection Order) and how this is communicated, opinion about whether the PSPO is effective, and also concern about dangerous dogs and dog control.

4. Results Analysis

There were eight surveys returned which is a low response rate. The drop-in session held on 28 June had two attendees, and no one attended the Zoom meeting.

We expected a low response rate because the NCCMP is very long and detailed, which means people would need a lot of spare time to read it. The NCCMP cannot be made any shorter because it needs to follow a prescribed structure, in line with guidance from various organisations including Historic England and the National Heritage Lottery Fund (NHLF).

A stakeholder consultation had been held previously in 2021, which allowed the Friends of Nunhead Cemetery and the Camberwell Cemeteries Working Group to review and comment on the CMP first. Many residents with a keen interest in the cemetery are likely to be members of these groups, and so would have already have had the opportunity to read the CMP and comment.

4. Equalities information and the profile of respondents

60% of respondents identified their sex recorded at birth as female. 20% identified as male and 20% did not answer this question.

Five people provided equalities information for this analysis. Three organisations (professional bodies, consultants or local community groups) returned comments on the CMP and did not return equalities information. The small data set can make the data misleading, and can also make it difficult to draw any firm conclusions.

Ethnicity

No respondents were from a black, Asian or ethnic minority background; 52% of the local population are from a black, Asian or ethnic minority background (2021 census), and they were not represented at all.

The consultation drop-in session was held in a Community Centre away from the cemetery, in the heart of the Nunhead community, and information was displayed locally and emailed to local faith groups some of which have black, Asian or ethnic minority members. We hoped to reach black, Asian and ethnic minority communities but unfortunately this was not successful.

80% of respondents stated they are from a white background. 48% of the local population is white (according to 2021 census data), so this shows that people from a white background were overrepresented.

Age

No responses were received from people aged under 34 years old. 49.4% of the local population are under 34 according to the 2021 census, showing that the views of children and young people were not represented at all.

40% of comments were from people aged 35 to 44 years old. 15.3% of the local population is within this age range showing an over representation.

Disability

40% of respondents to the survey stated that they have a disability, 40% stated they do not have a disability, and 20% did not answer the question. 17.6% of residents in Southwark are registered as having a disability. This is a good representation from people with disabilities.

Religion or belief

60% of respondents stated they have no religion, 20% stated they are Christian and 20% did not respond to this question. The Christian community is 45% so this is an under representation. 37.6% of the local residents identify as having no religion so this is an over representation.

People who have a religion and / or belief may have a greater interest in the cemetery, due to the fact that some religions require burial, and some require cremation. People from Christian and Muslim religious backgrounds are known to be buried at Nunhead Cemetery. An aim of this consultation was to get good representation from the Muslim community, and unfortunately this was not successful, with no representation from Muslims. We contacted local religious groups directly, but we did not receive any responses.

5. Conclusion

The consultation received a total of 8 responses, with 5 responding to the online survey and 3 responding by email. This is a low response rate as expected, however each respondent returned a large number of comments, with a lot of great suggestions on how to improve the NCCMP. The comments and suggestions are shown in full from page 5.

The groups who were under-represented or had no representation were black Asian and ethnic minority people, children and young people aged 34 years old and under, and those from religions other than Christianity, particularly the local Muslim community who are buried at Nunhead Cemetery.

The lack of representation of children and young adults is in line with cultural assumptions, which are generally that older people are more likely to be interested in historic environments than younger people. It may also be connected to lack of time being a barrier to consultation.

When preparing for the consultations for Camberwell Old and Camberwell New Cemetery CMPs we should consider how these groups can be reached more effectively, but also take into account that some members of our community are not interested in the detail that the CMPs provide.

Some respondents felt that the NCCMP was too long, and some mistakenly thought the NCCMP was a consultation questionnaire, rather than a CMP.

Although we have condensed the report as much as possible, the length of the NCCMP cannot be reduced, as every CMP must follow a standard format and structure, which is described on the Historic England webpage for conservation advice.

The council is going to make a funding application to the National Lottery Heritage Fund (NHLF) in November 2023, and they want us to send in our CMP for Nunhead Cemetery. The NHLF offer advice on what the CMPs must include, which can be found at <u>Heritage fund webpage for advice</u>.

The NCCMP will be formally adopted by the council, and will be available for use by the Bereavement Services team and anyone else who wants to use it.

The NCCMP contains a high level action plan, which provides the basis for the development of more specific and detailed action plans that will help council officers to secure future funding to carry out the actions.

Before the consultation began, we considered that the NCCMP document is very long, and that this may discourage some people from taking part in the public consultation. We considered providing a summary of the NCCMP, instead of the full document. However, we decided this would have been misleading, because a lot of information would have been missed out. Therefore we decided to provide the whole document as well as a summary, to make sure all of the information was available to the public, before the NCCMP is finalised.

Some respondents requested a summary version, split into sections on different themes, which had already been provided. The NCCMP document was split into eight sections. Each section had a brief summary to allow residents to choose which sections might be of interest to them, if they did not wish to read the whole NCCMP.

For the future consultations about Camberwell Old Cemetery CMP and Camberwell New Cemetery CMPs, we will again divide the document into sections, and include a summary of each section, alongside the full document.

Respondents mentioned that they like the view of St Pauls (Cathedral) and are pleased that it will be maintained. Some mentioned that during the warmer months, fast growing vegetation can block the view, and during the spring and summer it would need more maintenance.

The view of St Pauls Cathedral from Nunhead Cemetery is a protected view within the Southwark Plan and this is acknowledged within the CMP. The CMP contains an 'action plan', which states that the view should continue to be maintained within the cemetery by cutting back tree growth. Some residents were concerned that this was not happening regularly enough to retain this view. Unfortunately, the regularity of maintenance is limited by our maintenance budget. Should visitors notice that the view has become obscured, it would be helpful if they could inform council staff. No change to the CMP will be made, as a result of this feedback.

Some respondents felt that some of the Victorian graves need more maintenance, and that the vegetation also required more regular maintenance, so that more people can access inner areas of the cemetery.

The amount of maintenance that our team can carry out is limited by our maintenance budget. The NCCMP currently advises against cutting back vegetation to allow access to the inner areas of the cemetery. This is to protect the woodland environment and wildlife in these inner areas of the cemetery, and discourage visitors from treading new pathways that are not part of the historic path network, which we wish to protect. The NCCMP does recommend that vegetation should be maintained to the first row of graves and monuments which are set back from paths; this is already being carried out.

Once adopted, the NCCMP will be used to help the council decide how much money is required to maintain the cemetery, and apply for funding to support priority maintenance works

It was suggested that some new burials could be allowed, if done sensitively. No new burials take place at Nunhead Cemetery, except for second interments, as the last two active burial areas became full in 2022. There are currently no plans for new burial areas to be created, due to the lack of space and the cemetery's important status as a nature reserve.

There were also queries about woodland burials at Nunhead Cemetery. Woodland burials are not available at any of our cemeteries. Woodland burials are not currently an option at any of our cemeteries. The 2012 Cemetery Strategy notes that there was interest in woodland burials during public consultation, and suggests investigating where this could be provided, and that it may be at a new location outside of the borough, an possibly in partnership with another local authority.

Burial space in Southwark is running out due to the limited space in our cemeteries. Two respondents stated that they were opposed to the re-use of graves, which was the most popular suggestion in the 2012 public consultation regarding how to provide more burial space in Southwark's cemeteries. It was mentioned that public graves (also sometimes called common or pauper's graves) should not be re-used. It was suggested that re-using graves would be disrespectful the notion of what the cemetery was set up for. However, there was also a comment saying that graves should be re-used, highlighting the different opinions about this matter.

The re-use of graves is not currently being considered and cannot go ahead in the future without agreement from the Council Cabinet. The re-use of graves has not been proposed or considered at Nunhead Cemetery, therefore references to re-use have been removed from the NCCMP.

Some respondents said they found the NCCMP to be a very informative document, containing a lot of information that they did not already know. They suggested that this information should be provided at the cemetery, to enhance visitor's experience.

The project to restore the East Lodge in Nunhead Cemetery is considering visitor experience and providing boards with information about the cemetery in more detail.

Some requested that the signs showing information about the dog PSPO (Public Spaces Protection Order) could be improved. These signs show which areas dogs are only permitted on-lead, and where they can be off-lead.

The NCCMP contains a section about dogs and no changes are recommended. We will look at whether the signs can be made clearer.

It was mentioned that there are limited open areas at present, as most of the cemetery is a woodland and nature reserve. They felt this made the cemetery feel dark and cold, especially along the north-eastern edge.

The woodland (which covers much of the cemetery) creates shade and can be dark especially in the winter months. There are open areas in the southern areas of the cemetery, which creates a balance. The NCCMP recommends maintaining the existing balance of open and shaded/wooded areas. The woodland should not be reduced as it is an important habitat for wildlife and is protected within the Nunhead Cemetery Conservation Area designation, which means trees cannot be removed without a good reason, and planning permission. If a visitor feels unsafe in the darker wooded areas it is possible to walk through the cemetery by following the wider, more open-feeling pathways and glades.

6. Next Steps

The NCCMP has been updated following this public consultation and the final version was formally adopted on 1 December 2023.

Public consultation on the Camberwell Old Cemetery CMP and Camberwell New Cemetery CMP is expected to commence in 2024.
