### **The Upcoming Ballot**

Residents will be asked to vote in February 2021 in a ballot on the future of the Tustin Estate.

All those residents who have a vote in the Resident Ballot in February 2021 will, this month, receive the Landlord Offer Document.

The Landlord Offer document is Southwark Council's offer to you and includes:

- The commitments to residents
- The plans and designs
- Details of how to vote

The booklet has been designed to contain the information you need to make an informed decision about whether you are in favour of the redevelopment of the Tustin Estate or not.



### When will the ballot be?

The ballot will be held between Wednesday 10 February and Friday 5 March. The vote lasts for 23 days and closes at 5pm on Friday 5 March 2021.

If you are voting by post, your postal vote must be received by Tuesday 9 March 2021.

It is an independent ballot which is run by Civica Elections Services (CES) an impartial and independent organisation. Southwark Council will not be able to see how individuals have voted. It will manage the ballot process in line with Greater London Authority (GLA) guidance. CES is an independent company with over 100 years' experience of administering ballots and are the UK's leading provider of election services. They will be responsible for:

- Receiving and counting the votes
- Verifying that all votes have been casted legitimately
- Issuing the result

You will be able to vote using either of the following methods:

- Post the completed ballot paper back to CES in the pre-paid envelope provided.
- Vote online at www.cesvotes.com/tustinand provide the security code listed on your ballot paper.
- Call the Freephone number on your listed on your voting paper and provide the security code listed on your ballot paper.

Residents who are able to vote on the future of the Tustin Estate are anyone aged 16+ who are:

- Council tenants and any joint tenants who have been named on the secure tenancy agreement.
- Resident leaseholders who are named on the lease and have resided in their home for at least a year prior to the ballot.
- Resident freeholders who are named on the deed and have resided in their home for at least a year prior to the ballot.
- Residents who live on the estate as their principal home and have

been on the council's housing register for at least a year.

### **Trial Pits at Manor Grove**

Contractors have been asked to further investigate cracking to external brickwork at 81 Manor Grove. The investigation will provide a conclusive report on this property and proposed remedial work. They have external reviewed the area but to understand site conditions better they will be opening up a number of trail pits at Manor Grove.

#### Coronavirus

From Monday 4 January 2021, England moved into a new period of national restrictions, until Sunday 21 February 2021. This means that once again, we should all stay at home as much as possible and work from home if we can.

While this is hard for everyone, it is really important that we stick to the rules, so together we can reduce the number of people who are catching the virus, protect our families, friends and neighbours, and save lives.

The laws that the Government have introduced for this period mean you should only leave your home for specific purposes. These include to:

- Exercise outdoors or visit an outdoor public place
- Attend medical appointments or for any medical concerns or emergencies, including a booked Covid-19 test, or avoid harm or injury (such as domestic abuse)
- Go to work if you cannot work from home
- Shop for basic necessities like food and medicine
- Visit members of your support bubble, care for vulnerable people, or volunteer

Many businesses, such as pubs, nonessential shops, cinemas, leisure centres, museums and hair and beauty salons are closed.

Please be careful and make sure you protect yourself, your family and your friends, at all times.

If you think you have any of the COVID-19 symptoms you and anyone living with you should self isolate immediately and book a test by calling 119 or visiting

www.nhs.uk/coronvirus. Symptoms include:

- A high temperature
- A new, continuous cough
- A loss or change to your sense of taste or smell

If you have symptoms you and anyone you live with must stay at home and

self-isolate until you get your results. It is now a legal requirement to self-isolate if you've had a positive test or if you've been told to self-isolate by the national test and trace service.

### **Old Kent Road AAP**

The draft Old Kent Road Area Action Plan (December 2020) has been now been published and is available for consultation until 5 April 2021. It can be found at:

The draft AAP sets out an ambitious strategy for growth in the Old Kent Road area. Over the next 20 years the area will be transformed by the provision of new underground stations as part of the Bakerloo Line Extension, 20,000 new homes (including 5,000 social rented homes) and 10,000 additional jobs.

The 2020 draft AAP builds on the previous 2017 draft, emphasising the council's commitment to ensuring that the plan has a people focus which puts local residents, communities and others at the heart of the regeneration.

### **Rapid Testing Centre**

Southwark are currently encouraging key workers and those who can't work from home to get a lateral flow test. This includes school staff, supermarket staff, transport workers, security guards, cleaners, construction workers and many other roles.

Free rapid Covid tests are now available in Peckham. You should only have a rapid test if you do not have Covid symptoms. Yopu can book it through the Council's website www.southwark.gov.uk.

Here are some of the benefits:

- 1 in 3 people with COVID-19 have no symptoms. Check you're not carrying the virus and spreading it to work colleagues, or those you live with.
- Covid numbers are very high.
  Rapid tests help find more cases and help to control the virus.
- Rapid tests are painless and results are available in less than an hour.

The testing centre is at the Damilola Taylor Centre, 1e Surrey Grove, Peckham SE15 6DR and is open from 18 January 2021. It will be open from 9am to 7pm, seven days a week. More sites will open soon.

You should not book a rapid, lateral flow test:

- if you have COVID-19 symptoms.
  Instead, self-isolate and book a free NHS test on the government website.
- if you have been in close contact with someone who has tested positive for COVID-19. Instead, stay at home and self-isolate

If you test negative you must continue to follow the current Covid-19 rules.
