Welcome

Welcome to another monthly newsletter for the redevelopment of Daniels Road.

The Project Team

The project team consists of two Osborne personnel, Richard Ellis the Project manager and David Shields the Site Manager, totaling over 35 years of construction experience.

Upcoming Works

The project consists of the design and construction of 1No 3 Story Residential block of flats and 5 No houses with a total of 19 new council homes.

Block B – Block of Flats, we currently have the entire of the block wrapped in a scaffold for the installation of the external Brickwork which is ongoing over the coming Months. We have the Internal fit-out underway with 1st fix partitions in place and pipes and wiring being installed.

Block A - Town houses at South West of the site. We currently have the metal zinc roofing being installed. Internally we have installed the 1st fix pipework and cables along with the partition walls. Windows and doors are underway, and we have commenced the closing up of partitions ready for finishes.

Site Security – Monitored CCTV 24/7 is in place. Despite these measures we have been broken into twice in as many weeks.

Local Lettings

We are anticipating that the 19 new homes being built at Daniels Road will be ready to let in Spring 2021.

As you may be aware, Southwark Council will be letting all the new homes at council rents in accordance with its Local Lettings Policy. This means that half of the homes available at Daniels Road will be let exclusively to local residents* on the councils' housing register in Bands 1-3 via the bidding portal Homesearch. The remaining properties will then be advertised to all other applicants on the councils' housing register that are in housing need.

You must be registered on the councils' housing register and be in Bands 1-3 to bid for these homes. If you need to apply for the housing register, you can submit a Housing application form by visiting https://www.southwark.gov.uk/finding-a-new-home/looking-for-a-home?chapter=2 or by going to the Southwark Council website and selecting "Finding a new home" and "looking for a new home". Please check you meet the eligibility criteria before you complete your application.

A few weeks before the new homes are available, Southwark Council will write to local residents* that are registered in Bands 1-3 with the dates the new homes will be advertised on Homesearch.

*Please note the allocations team are currently looking into the housing need in the local area so that we can define how far the local lettings area will be set from the development.
