



# Slippers Place update

## August 2019

Your quarterly update about the development of new homes at Slippers Place.

### What you need to know:

We're creating new homes at Slippers Place car park as part of our commitment to providing more quality council homes across the borough. We've committed to creating 11,000 new council homes by 2043 – a big goal, but crucial if we're going to tackle the housing crisis and ensure our residents have quality homes they can be proud of, now and in the future.

We're building 18 new homes. These new homes will be built on the car park area and where the pram sheds stand.

- 50% will be prioritised for existing residents of Slippers Place who are in housing need, so they can continue to live near family, friends, and services they currently use.
- 50% will be allocated to people on our wider housing waiting list.

### Timeline

<b>November 2019</b>	Pre-planning event Open drop-in event to show final design, for all residents on the estate
<b>Early 2020</b>	Planning submission & approval
<b>Summer 2020</b>	Meet the Contractor event Opportunity for residents & project group to ask questions and information about the works that will be starting on site.
<b>Late 2020</b>	Construction work starts on site

## Latest updates

As normal procedure, whilst architects are designing the new homes, surveys are undertaken to investigate utilities services that run beneath Slippers Place car park. The findings of these surveys were analysed by engineers but unfortunately, further specialist investigations were also required and are now complete.

Engineers and the new homes team are now discussing with the utilities companies how best to design and build the new homes without disturbing these services.

Once we have an agreement in principle with the utility companies, we will continue with the design of the new homes which will involve another resident project group meeting (Slippers Place project group). We hope to hold this project group meeting in October 2019.

## Working with you

It's really important to us that we work with residents when we create new homes in Southwark.

As part of creating new homes at Slipper Place car park, we work alongside a project group made up of representatives from the local estate, local stakeholders and a number of Slippers Place residents.

The group meets regularly with others involved in the new homes project, such as architects and project managers, to help us decide how we're going to deliver new homes in a way that benefits everyone.

## Your views

### Concerns raised by residents

#### Potential overlooking of nearby homes and loss of Daylight and sunlight

There will be a daylight and sunlight survey to assess the impact of the new development with regards to existing properties. New developments are subject to planning policies and regulations, and the local planning authority will also assess any possible overlooking issues of new buildings and therefore, we need to make sure that any potential negative effects are addressed accordingly.

The current proposed massing and shape of the new building has been carefully considered to minimise any overshadowing and impact on privacy, the building's elevations had been angled to avoid direct overlooking of windows and gardens.

#### Loss of parking bays in the estate.

We will instruct an independent company to carry out a car parking survey to determine parking needs and parking availability in the area. Surveyors will also complete a transport assessment to evaluate public transport links and any possible issues related to the proposed development; the proposed development would be considered car-free, except for the wheelchair units which have a disabled parking bay nearby.

## Size and height of new building:

Please note this new building is at design stage, architects are working in the plans and drawings on what it is considered to be the best approach for the new building based on the existing homes, surrounding area and the outcome of various surveys we are carrying out. During this design stage, we meet with the resident's project group to provide updates, listen to their concerns and suggestions. We aim to develop a scheme that meets planning policies and provides high quality homes

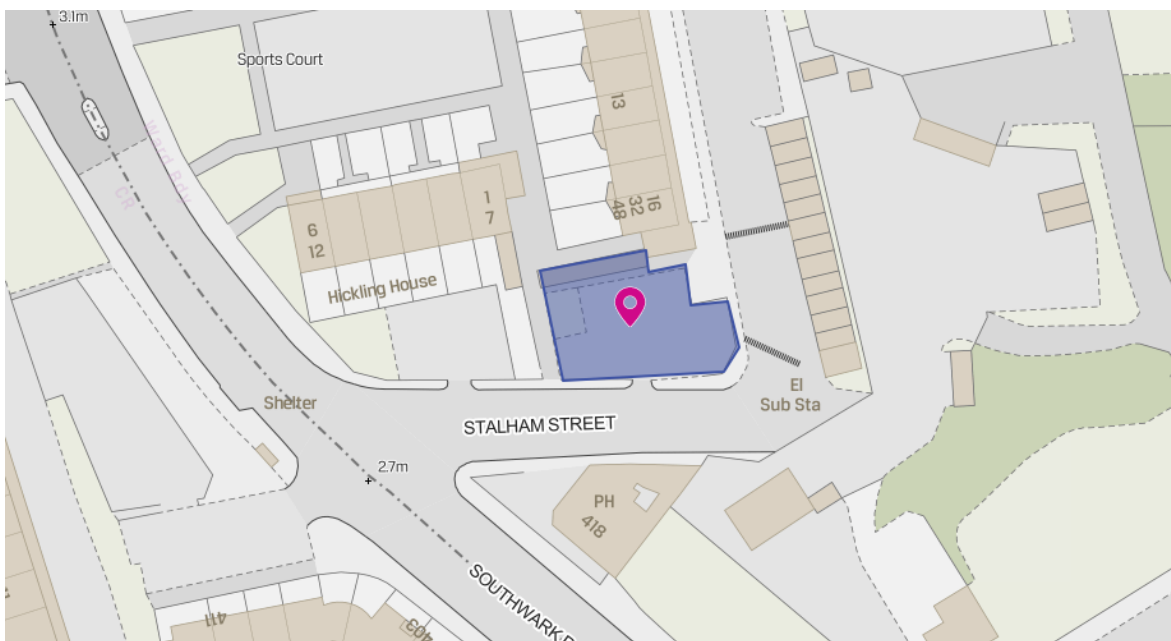
