

**New Southwark Plan Examination Hearing Programme v.2
for On-line Hearing Sessions
8 February 2021**

Please note this is a revised timetable for the hearings which updates the previous version of 11 December 2020 [examination document EIP89]. Due to a number of circumstances arising from the current lockdown it has been necessary to significantly amend the hearings programme. **The hearings will now take place in 2 parts.** The first part will still open on 23 February 2021 at 10am and hearings will be held into the proposed strategy and policies of the New Southwark Plan over 3 weeks until 10 March. The second part will take place from 20 April and will consider the proposed sites in the Plan, together with policies for the delivery of the plan.
