Project update

What we've completed

Since our previous issue we have completed the removal of plantation including a number of trees that are in the footprint of the new buildings. Please note replacement trees will be planted when the scheme is completed.

We have also completed demolition of the existing garages and reduced the existing wall.

What we're doing now and next

We are currently continuing with the excavation of the ground (also known as reducing dig) across the site to get to the correct level so we can start constructing the foundations.

Over the coming weeks we will be looking to start the installation of the attenuation tank (*This is a water tank underground that collects rainwater and surface water*) as part of the Sustainable Urban Drainage System (SUDS). This is planned to take no more than 15 days to complete.

We will also be installing a cross over (*This is a dipped curb like you would find in front of a private driveway*) on Rye Hill Park to allow us access and egress to the higher section of the project. This should take no more than seven days to complete.

The installation of sheet piling will follow these works which will retain the grass area on site. This is planned to take no more than 10 days to complete.

The works listed above will be noisy however we will try to minimise noise wherever possible and apologise for any inconvenience caused.

Please note we will be working Saturdays between 9am-2pm. We will try to avoid working at weekends and will only do so if absolutely necessary.
