UPDATE ON THE PROPOSAL FOR NEW COUNCIL HOMES

DECEMBER 2020 – FENWICK ROAD

We're proposing to build new council homes on Fenwick Road as part of our commitment to providing more quality council homes across the borough. We've committed to creating 11,000 new council homes by 2043 – a big goal, but crucial if we're going to tackle the housing crisis and ensure our residents have quality homes they can be proud of, now and in the future.

The proposed new development will provide new council homes at council rents. A minimum of 50% of these new council homes will be let to existing local residents in housing need in line with the Council's local lettings policy. This means residents can continue to live near family, friends, and services they currently use. Fenwick Road is one of over 120 infill, rooftop and redevelopment sites we are working on across the borough. Alongside the development of new homes, we will carry out some improvements to the area surrounding the development site. We have already received some great suggestions from residents for works that could be carried out, for example, improvements to the bin storage and communal garden at the back of 55-77 Fenwick Road. The plans for the improvements will be based upon residents' ideas and feedback.

LATEST UPDATES

We held an open event on 4th October for local residents to meet the project team. Residents met with the architect's from Stolon Studio and the employer's agents from Potter Raper.

Stolon Studio provided a presentation of the character, appearance, constraints of Fenwick Road and they shared some early thoughts about the design of the building and the shared garden.

Potter Raper outlined their roles and responsibilities whilst working on the project, for example, preparing tenders for contractors and ensuring that the project is achieved within the specified time frames.

Following the open event we asked residents if they would be interested in joining a Project Group to work on developing the proposals for the new homes in more detail. The Project Group has now been formed and is made up of 10 residents.

The first project meeting was held on 4th November. The Project Group will be working with the architect to share their views and provide comments on the proposals as they are developed.


