#### **Estate Wide Zoom Meeting**

Thank you so much to those of you who attending the Zoom meeting on Wednesday 7 April, 2021. If you missed it, the meeting was recorded and it can be viewed on the Tustin website at https://tustin.estate/

#### **Leaseholder Buy Backs**

At the resident estate-wide Zoom meeting, leaseholders asked whether the council would be in a position to buy back their homes now. It was confirmed that the council would be as soon as the scheme is approved by Southwark's Cabinet at their July 2021 meeting. Leaseholders will learn more at the estate-wide Zoom meeting for leaseholders on Thursday 3 June, 2021 at 6pm. The joining details will be circulated nearer the time.

Homes will be bought back at the market value. There will therefore be variations between different properties in the same block, depending on a number of factors including their internal condition, aspect and external space. Resident leaseholders will be paid an additional 10% home loss payment and non-resident leaseholders an additional 7.5% basic home loss payment.

#### Hillbeck Close

Thank you very much to the tenants in Hillbeck Close who have so far spoken to Sharon Burrell from the Tustin team to find out whether they would like to be:

 permanently moved away from the estate

- permanently rehoused in one of the tower blocks that are staying up on the estate
- temporarily rehoused on the estate whilst waiting for a new home in one of the new build blocks that are being built

As you know the site of Ullswater House and Hillbeck Close will be where the first new homes will be built. To allow this to happen, Hillbeck Close needs to be empty.

Once we have completed all the calls we will be writing to the tenants concerned to let them know what will happen next.

Separate calls are being organised for leaseholders to go through the options available for them.

### **The Tustin Resident Project Group**



## COVID-19 vaccination centre in Old Kent Road ASDA

Part of the George clothing department has been given over to the vaccination clinic, which will be overseen by Asda's in-store pharmacy team.

Patients will be invited by the NHS to book vaccination appointments at Asda. It will not be possible to book directly with the supermarket.

The Asda Old Kent Road store will join a growing network of vaccination centres in SE1, including Guy's Hospital and St Thomas' Hospital. Local GP practices in north Southwark are also offering jabs at the Artesian Health Centre in Bermondsey.

The St George's Pharmacy at the Elephant & Castle has also been approved by NHS England to provide COVID-19 vaccinations.

### Reminder - Old Kent Road Area Action Plan -Consultation Deadline Extended

Further to the article in last month's newsletter, the consultation deadline for the Old Kent Road Area Action Plan (AAP) has been extended to 10 May 2021.

The Old Kent Road AAP is an innovative plan for regeneration and development in the Old Kent Road Opportunity Area.

The plan proposes a new masterplan for 18 key strategic development sites in five distinct sub areas. The plan is designed to integrate new and existing communities to deliver facilities, services, open spaces, housing, and employment that all local residents can benefit from.

Since the council consulted on the draft Old Kent Road AAP in December 2017, we have approved close to 9,000 additional homes. We have 7 schemes and 640 homes on site at the moment, and approximately 160 homes completed. However there is still scope to influence and direct development, so we welcome your comments on the latest draft AAP.

The Old Kent Road AAP has been through a number of consultations, and the current version of the plan is the December 2020 draft. Consultation on this version began on 11 January and has been extended until 10 May 2021.
