Executive Summary

This report provides details of the updated provisional Dedicated Schools Grant (DSG) allocation for 2015-16.

Schools Forum Actions

The Schools Forum is asked to note this report.

1.0 Background

1.1 On 17 December 2014, the Education Funding Agency (EFA) announced the 2015-16 Dedicated Schools Grant (DSG) settlement. This was a provisional allocation, with a number of further adjustments expected during the year. This report provides the Schools Forum with details of adjustments to the DSG settlement that have now been finalised.

2.0 2015-16 Dedicated Schools Grant Allocation – March 2015

- 2.1 The updated DSG allocation announced on the 26 March 2015 is £290.340m, an increase of £1.639m prior to deductions for academies recoupment and high needs places. A summary of the changes are outlined in Appendix A.
- 2.2 The main change is the increase in the non-recoupment academies cash transfer. As reported at the January 2015 meeting, a further adjustment was expected to reflect the estimated numbers for those academies which are new or still adding year groups to maintain the principle of cash neutrality for these changes in 2015-16. The LA set the original DSG budget in line with this principle of cash neutrality, with the final cash transfer estimated based on the updated pro-forma calculation. This increase has therefore been accounted for as part of the original DSG budget setting process.
- 2.4 The Schools Forum is asked to note that this is not the final DSG allocation, with a number of further adjustments expected during the year. As reported previously, the risk of differences between estimated and actual funding will be managed using the current contingency held in reserves. An updated summary of the in-year changes expected is outlined in Appendix B.

3.0 2014-15 Final early years block adjustment

3.1 On the 22 May 2015, the EFA confirmed the final 2014-15 DSG allocation, updated to reflect pupil numbers from the January 2015 school and early years census returns.
