## **Executive Summary**

This report provides the Schools Forum with details on the level of balances held by maintained schools at the end of the 2014-15 financial year.

### **Action for the Schools Forum**

The Schools Forum is asked to note this report.

### 1.0 2014-15 Provisional Maintained School Balances

1.1 The provisional year-end balances show a total increase in balances held by schools of £2.7m; from £18.3m to £21.1m. A summary of the balances held at the end of the 2014-15 financial year is provided in the table below:

2.3 In total, there were three schools with deficit balances at the end of 2014-15. The schools finance team will be working with these schools as part of the 2015-16 school budget setting process.

#### 3.0 The Balance Control Mechanism

- 3.1 Southwark continues to operate a balance control mechanism, with the operation of the mechanism relaxed in previous years. Under this arrangement the LA continues to monitor and scrutinise the level of balances held but claw back of balances would only be sought where schools are holding significant excessive uncommitted balances for excessive periods.
- 3.2 The balance control mechanism threshold is set at 5% of budget share for secondary schools and 8% of budget share for primary, special and nursery schools.
- 3.3 There are currently 49 schools (62% of maintained schools) holding balances in excess of the balance control mechanism threshold. This represents a total of £8.8m funding being held by schools in excess of the threshold levels. The Schools Forum is asked to note that this figure excludes the additional one-off funding of £4m that has been allocated to schools in 2015-16 from previous year Dedicated Schools Grant underspends.
- 3.4 A breakdown of the number of schools holding balances in excess of the threshold by phase is outlined in the table below:

- 4.2 Further details will be reported to future meetings if any schools are identified as requiring additional monitoring and scrutiny of the balances held.
