Welcome

Welcome to another monthly newsletter for the redevelopment of Daniels Road.

The Project Team

The project team consists of three Osborne personnel, Richard Ellis the Project manager, David Shields the Site manager and Leire Saavedra the Site manager, totaling over 39 years of construction experience.

Upcoming Works

The project consists of the design and construction of a 3 storey residential block of flats and 5 houses providing a total of 19 new council homes.

Block of Flats

Externally:

- Brickwork completion
- Powder coated balconies and railings
- Downpipes and zinc cladding

Internally:

- Wall closures and plastering works
- Lift installation
- Main stairs and walkways

Houses Internally works are completed, snagging is underway. Externally, works being carried out:

- Bin stores and patios,
- Fencing to the gardens
- Paving of the rear entrances.

Practical Completion - We anticipate completion mid-summer 2021. Due to the Global Pandemic we have only managed to operate at 50% capacity due to welfare restrictions and social distancing guidelines.

Local Lettings

Southwark Council will be letting all 19 new homes at Daniels Road at council rents in accordance with their Local Lettings Policy. This means that half of the homes available at Daniels Road will be let exclusively to local residents* on the council's housing register in Bands 1-3 via the bidding portal, Home search.

The remaining properties will then be advertised to all other applicants on the council's housing register that are in housing need. You must be registered on the council's housing register and be in Bands 1-3 to bid for these homes. If you need to apply for the housing register, you can submit a Housing application form by visiting <https://www.southwark.gov.uk/finding-a-new-home/looking-for-a-home?chapter=2> or by going to the Southwark Council website and selecting "Finding a new home" and "looking for a new home". *Please check you meet the eligibility criteria before you complete your application.*

A few weeks before the new homes are available to let Southwark Council will write to local residents* that are registered in Bands 1-3 with the dates the new homes will be advertised on Home search.
