Welcome to the latest edition of the Tustin Estate monthly newsletter from Southwark Council.

Now that the residents of the Tustin Estate have voted for the demolition and rebuild of Bowness House. Heversham House. Hillbeck Close and Kentmere House, and the refurbishment of the council houses on Manor Grove, there is plenty to do.









Tustin Estate proposals being considered by Southwark's Cabinet

Following the residents ballot earlier this year, this month the council's Cabinet will receive a report on making sure that the promises made will be delivered.

Don't forget, over the next year we will be working with residents to:

- secure planning permission
- secure an agreement with a builder to carry out the works
- begin pre-allocations discussions with all residents in properties to be demolished

As part of the Cabinet report it is proposed that:

- We can start negotiations with Leaseholders. We will start discussions with Hillbeck Close leaseholders as a priority and then other blocks
- We can start re-housing of the permanent council tenants in Hillbeck from August
- We will start talking to residents in Kentmere about their housing need
- Demolition notices will be issued to residents in the low rise blocks.

What is a demolition notice? A demolition notice is required as part of an estate redevelopment, such as with the current proposals on the Tustin Estate.

A demolition notice will be issued to inform residents in Hillbeck Close, Kentmere House, Heversham House and Bowness House that the council

intends to proceed with the redevelopment plans that will involve demolishing their home in the future.

Demolition notices are issued in two stages, with the first notice issued to residents when the local authority is planning to demolish their property within the next seven years. It does not mean that demolition work is about to start.

Once a demolition notice has been served it will temporarily suspend or end a qualifying tenant's Right to Buy (RTB) claim (for up to seven years) until they move into their new home. It does not affect homeowners who have already bought their homes.



Kentmere House

We have now spoken to everyone in Hillbeck Close as they are the first people that need to move. The site of Ullswater House and Hillbeck Close will be where the first new homes will be built. To allow this to happen, Hillbeck Close needs to be empty.

We now need to speak to everyone in Kentmere House, Heversham House and Bowness House.

We will be starting with Kentmere House in September and will be speaking to

everyone after that to find out what they want to do, what size home they will need and to help them register for housing.

By next year we will have the designs and layouts of all the new homes being built on the estate. We will write to everyone who wants to remain on the estate with the layout of the new homes, so that you will then be able to let us know which of the new flats you would like to move in to which will be available from summer 2024.

Step 3 restrictions continue

On Monday 14 June the Government announced it was delaying the move into Step 4 of the Roadmap due to the increase in COVID-19 rates caused by the Delta variant. This means that we will stay in Step 3 until Monday 19 July (the Government will review and make a new announcement on 12 July). There

are a few small changes including removing the limit of 30 people at life events like weddings and wakes, although number will still be subject to venue capacity and social distancing measures.

This means:

- Groups of up to 30 can meet outdoors
- Rule of 6 indoors
- Indoor hospitality opens (e.g. pubs and restaurants)
- Indoor entertainment opens (e.g. cinemas)
- Increasing numbers for life events like weddings and removal of restrictions for funerals

It remains essential that we take these steps carefully and sensibly. Continue to work from home if you can. If you plan to travel do so safely and plan ahead. You should continue to wear a mask where required (unless exempt), wash hands and maintain social distancing when out in public.

If you think, you **have** any of the COVID-19 symptoms you and anyone living with you should self-isolate immediately and book a test by calling 119 or visiting

www.nhs.uk/coronvirus.

Symptoms include:

- A high temperature
- A new, continuous cough
- A loss or change to your sense of taste or smell

If you have symptoms, you and anyone you live with **must** stay at home and self-isolate until you get your results. It is now a legal requirement to self-isolate if you have had a positive test or if you are told to self-isolate by the national test and trace service.

Keep testing

One in three people could be carrying the COVID-19 virus without showing any symptoms. As part of coming out of lockdown safely everyone should be getting tested regularly – even if they don't have symptoms. Home tests are now available for FREE to every household in the UK.

There are a number of ways you can get a test:

 There are now 45 community pharmacies in Southwark offering home test collection, including 10 who offer assisted testing. The map below shows all the current provision: https://maps.test-andtrace.nhs.uk/
