The independent firm of architects and surveyors (Hunters) we appointed to develop some options for the future of Ledbury Towers have now suggested four options:

- A. A basic refurbishment of the towers to meet health and safety essential standards, paid for from the Housing Revenue Account.
- B. A higher standard of refurbishment of the towers plus building new homes around them for local overcrowded families and other local residents in housing need; the additional refurbishment expenditure and the cost of the new council homes being partly met from the sale of new homes and partly from the Housing Revenue Account.
- C. A mixture of refurbishment to the higher standard, and demolition of some, but not all, towers with a replacement of new homes for local overcrowded families and other local residents in housing need; the additional refurbishment expenditure and the cost of the new council homes being partly met from the sale of new homes.
- D. Demolition of all four towers, and replacement with new homes; the additional cost of the new council homes, being partly met from the sale of new homes.

If options B, C or D are chosen, we will work closely with residents to develop detailed plans for the new homes.

Southwark Council's Cabinet will be considering a report from Hunters at the end of October 2018 on the future of the Towers. Before the Cabinet makes a decision, they want to understand the views of residents and former residents with the right to return about each of these proposals. We want you to let us know which options you prefer so your views are taken into account when the Cabinet makes the decision about the next steps.

There is a display in the Ledbury TRA Hall on the four options over the next two weeks. There will be an open meeting on Thursday 6 Sept 2018 at 7pm to hear about the options. Staff from Hunters will also be available at the Hall on the following days to discuss the options and answer any questions you may have:

- Thursday 30 August 2018 from 2pm until 8pm
- Thursday 6 September 2018 from 2pm until 7pm

The questionnaire needs to be returned by Sunday 9 September 2018. If you can not get out, please let your Resident Services Officer know, and they can collect the envelope from you to post into the box.

#### A. – A basic refurbishment of the Towers

The refurbishment works include at least the following:

- Permanent fire stopping, any fire risk assessment works required and installation of a sprinkler system
- Structural reinforcement works to all affected areas
- New kitchens, bathrooms and WCs.
- Making good cracks / gaps between external wall panels and intermediate cross-wall panels.
- Heating and electrical remedial works.
- Communal TV System
- Renewal of all service pipes, waterproofing to kitchens, WC and bathroom floors, renewal of
  existing soil stacks and renewal of communal cold water tanks.
- Improvements to ventilation to stairways and landings

# **B.** – A higher standard of refurbishment of the Towers plus building new homes around them

<u>This will include all of the refurbishment works set out in Option A</u> plus building a number of new homes around the Towers. At least 35% of the new homes will be at council rents, and 50% of these will be offered first to Ledbury tenants in need of rehousing.

The homes built for sale will help Southwark Council pay for the following extra works to the Towers:

- Renew existing lifts and improve lighting to stairways and communal areas
- Provide improved insulation to flats and communal areas.
- Repair/renew key building components such as roofs and windows
- Improve water pressure to upper floors
- Communal satellite and broadband

# C. – Partial refurbishment to the higher standard, and demolition and replacement with new homes

This will include the demolition of some of the Towers; the Towers that remain will be refurbished as set out in Option A. The Towers that are demolished will be replaced with new homes. The number of refurbished and new homes at council rent will be at least the same number of council homes currently provided in the Towers. Examples of those options are on display in the Ledbury TRA Hall.

# **D.** – Demolition of Bromyard, Peterchurch, Sarnsfield and Skenfrith Houses, and replacement with new homes

This will include the demolition of all four Towers. The four Towers will then be replaced with new homes. Examples are on display in the Ledbury TRA Hall. The number of new homes at council rent will be at least the same number of council homes currently provided in the Towers.

If Options, B, C or D are chosen, we will work closely with residents to develop detailed plans for the new homes.
