The London Borough of Southwark (Charged-for parking places) (East Faraday Streetspace) Order 202* The London Borough of Southwark (Prescribed routes) (East Faraday Streetspace) Traffic Order 202* The London Borough of Southwark (Waiting and loading restrictions) (East Faraday Streetspace) Order 202*

- Southwark Council hereby GIVES NOTICE that it proposes to make the above Orders under the Road Traffic Regulation Act 1984, as amended ('the 1984 Act').
- 2. The effect of the Orders would be, on a permanent basis:-
- (a) to introduce a point road closure in BAGSHOT STREET prohibiting the movement of motor vehicles between its junctions with Smyrks Road and Mina Road, which would be indicated by traffic signs and physically enforced by planters and flexible bollards;
- (b) in MINA ROAD in Controlled Parking Zone 'M1' south-east side o/s Walworth Academy, (i) remove two 'permit' holders parking places (total 30m in length removed), and (ii) replace with timed waiting restrictions which operate '8.30 am to 6.30 pm Monday to Friday'; and
- (c) in SHORNCLIFFE ROAD (i) on the north-west side o/s Walworth Academy add 33.5m of timed waiting restrictions which operate '8.30 am to 6.30 pm Monday to Friday', and coterminous loading restrictions which operate '8.30 to 9.30 am, 3 pm to 6.30 pm Monday to Friday', and (ii) add 'at any time' waiting restrictions on both sides of the road throughout the remaining kerbside between its junction with Albany Road and the boundary of the Transport for London Road Network ('red route') at a point 21 metres south-west of the south-western kerb-line of Old Kent Road.
 - NOTES: (1) These Orders would supersede similar provisions at the above locations implemented by way of experimental Orders made under section 9 of the 1984 Act (which would be revoked). (2) Exemption to the restrictions described in (a) preceding would be provided for emergency services vehicles, and for vehicles used for road maintenance or cleansing purposes. (3) All measurements are in metres 'm' and are approximate.

Citation and commencement

1.1 This Order may be cited as the London Borough of Southwark (Charged-for parking places) (East Faraday Streetspace) Order 202* and shall come into force on 202*.

Interpretation

2.1 In this Order:-

"Council" means the Council of the London Borough of Southwark;

"enactment" means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment;

"map-based schedule" means the map attached to and to be read in conjunction with this Order and the Order of 2021, which depicts the parking place designated by this Order, and, in conjunction with the map schedule legend, identifies the type of each particular parking place and, if appropriate, certain of its governing provisions:

Provided that the Council does not accept responsibility for any inaccuracies contained in the Ordnance Survey data relied upon to create the map-based schedule and where a parking place is depicted on the map-based schedule, that parking place will continue to apply irrespective of any subsequent changes that have been made to the underlying Ordnance Survey data.

"map schedule legend" means the map schedule legend attached to this Order which, when used in conjunction with the map-based schedule, identifies the specific type of parking place designated by this Order and, where appropriate, certain of its governing provisions;

"the Order of 2021" means the London Borough of Southwark (Charged-For Parking Places) (Map-based) Order 2021^b; and

"traffic sign" means a sign of any size, type and colour prescribed or authorised under, or having effect as though prescribed or authorised under, section 64 of the Road Traffic Regulation Act 1984

- 2.2 Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- 2.3 Unless the context otherwise requires, any expression used in this Order which is also used in the Order of 2021 shall have the same meaning as in that Order.

Amendment of items in the map-based schedule

- 4.1 Without prejudice to the validity of anything done, or to any liability incurred in respect of any act or omission before the coming into force of this Order, the Order of 2021 shall have effect as though:-
 - (a) where there is no existing item at a location depicted in the map-based schedule attached to that Order, there were added to that map-based schedule the item depicted in the map-based schedule attached to this Order; and
 - (b) where there is an existing item at a location depicted in the map-based schedule attached to that Order, there were substituted in that map-based schedule the item depicted in the map-based schedule attached to this Order.
- 4.2 The amendment referred to in Article 4.1 of this Order of an item in the map-based schedule will have the effect of revoking any provision provided or designated by a previous version of that item in the map-based schedule and not incorporated into the latest version.

Designation of parking place and application of the Order of 2021 thereto

- 5.1 Each area on a street identified the map-based schedule as a parking place and, where applicable, by way of the map schedule legend as an area marked out and signed for the use therein of specified classes of vehicles following the conditions specified in the Order of 2021 in relation to that type of parking place, is designated as a parking place.
- 5.2 Unless otherwise so identified, a parking place shall be bounded on one side of its length by the edge of the carriageway and be an area marked either by a traffic sign or by another method of indicating the extent of a parking place as specified in the Traffic Signs Regulations and General Directions 2016°.
- 5.3 The provisions of the Order of 2021 (other than Articles 4 and 19) shall apply to the area designated as a parking place by this Order as if in those provisions any reference to a parking place included a reference to an area designated as a parking place by this Order.

Placing of traffic signs, etc

- 6.1 The Council shall:
 - (a) place and maintain traffic signs or other appropriate markings on the surface of the street indicating the limits of the parking place designated by this Order;
 - (b) place and maintain in or in the vicinity of each parking place, traffic signs indicating that such parking place may be used during the permitted hours for the leaving only of the vehicles specified in Articles 5.1 and 5.2 of the Order of 2021; and

(c) carry out such other work as is reasonably required for the purpose of the satisfactory operation of a parking place.

"kerb-line" means the imaginary line which is the projection of the line formed by the edge of the carriageway of a street;

"motor vehicle" has the same meaning as in section 136 of the Road Traffic Regulation Act 1984;

"prescribed street" for the purposes of Article 4.1 of this Order means the parts of streets referred to in Articles 3.1 and 3.2 of this Order; and

"traffic sign" means a sign of any size, type and colour prescribed and authorised under, or having effect as though prescribed or authorised under section 64 of the Road Traffic Regulation Act 1984

2.2 Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.

Prescribed routes

Bagshot Street

- 3.1 No person causing any motor vehicle to proceed in that part of Bagshot Street which lies southeast of a point 6 metres south-east of the south-eastern kerb-line of Smyrks Road shall, upon reaching that point, cause that motor vehicle to enter that part of Bagshot Street which lies northwest of a point 6 metres south-east of the south-eastern kerb-line of Smyrks Road.
- No person causing any motor vehicle to proceed in that part of Bagshot Street which lies north-3.2 west of a point 6 metres south-east of the south-eastern kerb-line of Smyrks Road shall, upon reaching that point, cause that motor vehicle to enter that part of Bagshot Street which lies southeast of a point 6 metres south-east of the south-eastern kerb-line of Smyrks Road.

Exemptions

- 4.1 Nothing in Articles 3.1 and 3.2 of this Order shall apply in relation to:
 - anything done with the permission or at the direction of a police constable in uniform;
 - any vehicle being used for ambulance, fire brigade or police purposes: (b)
 - any person who causes any vehicle to proceed in accordance with any restriction or (c) requirement indicated by traffic signs placed on the highway pursuant to section 66 or section 67 of the Road Traffic Regulation Act 1984;
 - (d) any vehicle being used for the maintenance, improvement, re-construction, cleansing or lighting of that part of street; and
 - any vehicle being used in connection with the laying, erection, alteration, or repair in or (e) adjacent to a prescribed street of any sewer, main, pipe or apparatus for the supply of gas, water, electricity, or of any electronic communications network (as defined in section 32 of the Communications Act 2003b); or the placing, maintenance or removal of any traffic sign, if the vehicle cannot be used for that purpose in any other street or part thereof.

Revocation

5.1 Without prejudice to the validity of anything done, or to any liability incurred in respect of any act or omission before the coming into force of this Order, the London Borough of Southwark (Prescribed routes) (Bagshot Street) Experimental Traffic Order 2020c is hereby revoked.

Provided that the Council does not accept responsibility for any inaccuracies contained in the Ordnance Survey data relied upon to create the map-based schedule and where a waiting restriction is depicted on the map-based schedule, that waiting restriction will continue to apply irrespective of any subsequent changes that have been made to the underlying Ordnance Survey data.

"map schedule legend" means the map schedule legend attached to this Order which, when used in conjunction with the map-based schedule, identifies the specific type of waiting restrictions imposed by this Order and, where appropriate, certain of their governing provisions; and

- "the Order of 2021" means the London Borough of Southwark (Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) (Map-based) Order 2021b.
- 2.2 Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- 2.3 Unless the context otherwise requires, any expression used in this Order which is also used in the Order of 2021 shall have the same meaning as in that Order.

Substitution of items in the map-based schedule

- Without prejudice to the validity of anything done, or to any liability incurred in respect of any act or omission before the coming into force of this Order, the Order of 2021 shall have effect as though for the existing items at the location depicted in the map-based schedule attached to that Order, there were substituted in that map-based schedule the items depicted in the map-based schedule attached to this Order.
- 3.2 The substitution referred to in Article 3.1 of this Order of an item in the map-based schedule will have the effect of revoking any provision provided or designated by a previous version of that item in the map-based schedule and not incorporated into the latest version.

Waiting restrictions and loading restrictions applicable to restricted streets

Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the Order of 2021 shall have effect as though any waiting restriction or loading restriction identified in the map-based schedule and by way of the map schedule legend and marked out and signed as a waiting restriction or a loading restriction shall be construed as through it were a restricted street referred to in the Order of 2021.

Revocation

5.1 Without prejudice to the validity of anything done, or to any liability incurred in respect of any act or omission before the coming into force of this Order, the London Borough of Southwark (Waiting and loading restrictions) (Amendment No. 20) Experimental Traffic Order 2020° is hereby revoked.

This Order, amends items in the map-based schedule attached to the Order of 2021, so as to permanently, as part of East Faraday Streetspace:-

- (a) add SYLs operating '8.30 am to 6.30 pm Mon to Fri' in Mina Road south-east side and Shorncliffe Road north-west side o/s Walworth Academy;
- (b) in Shorncliffe Road north-west side o/s Walworth Academy add loading restriction (single kerb blips) '8.30 to 9.30 am, 3 pm to 6.30 pm Monday to Friday'; and
- (c) adds and amends DYLs throughout the remaining kerbside on both sides of Shorncliffe Road, between its junction with Albany Road and a point 21m south-west of the south-western kerb-line of Old Kent Road.
