- 2. The effect of the Orders would be, on a permanent basis: -
- (a) to provide 'no motor vehicles' restrictions (i) in AMELIA STREET and (ii) in ILIFFE STREET at their junctions with Penton Place;
- (b) to provide a 'no motor vehicles' restriction in PENTON PLACE at its junction with Kennington Park Road:
- (c) in Controlled Parking Zone 'E' amend the following permit holders parking places: (i) in AMELIA STREET north-west side 6m removed o/s No. 230 Amelia Street, and reduced on the southeast side (53m remains) opposite Nos. 196 to 210 Amelia Street, (ii) in ILIFFE STREET reduce on both sides by 6.5m per side north-east of its junction with Penton Place:
- (d) in AMELIA STREET south-east side remove 12m 'pay' parking opposite Nos. 212 to 226 Amelia Street;
- (e) in PENTON PLACE south-west side add 16m 'permit' parking opposite No. 45 Penton Place;
- (f) to amend 'at any time' waiting restrictions to accommodate the above-mentioned changes in AMELIA STREET, ILIFFE STREET and PENTON PLACE.
 - NOTES: (1) These Orders would supersede similar provisions at the above locations implemented by way of experimental Orders made under section 9 of the 1984 Act (which would be revoked). (2) Exemption to the restrictions described in (a) and (b) preceding would be for emergency services vehicles, vehicles used for road maintenance or cleansing purposes and refuse collection; for (b) preceding, exemptions also provided for postal service, taxis and (on a discretionary basis) disabled persons vehicles (registered to Southwark resident 'blue badge' holders), rapid response healthcare workers vehicles and SEND vehicles. (3) All measurements are in metres 'm' and are approximate.

3.1 No person shall cause any motor vehicle to enter into or proceed in that part of Amelia Street which lies between a point 2 metres north-east of the north-eastern kerb-line of Penton Place and a point 13 metres north-east of that kerb-line.

 - (a) anything done with the permission or at the direction of a police constable in uniform;
 - (b) any vehicle being used for ambulance, fire brigade or police purposes;

Amendment of items in the map-based schedule

- 3.2 The amendment referred to in Article 3.1 of this Order of an item in the map-based schedule will have the effect of revoking any provision provided or designated by a previous version of that item in the map-based schedule and not incorporated into the latest version.

Designation of parking place and application of the Order of 2021 thereto

- 4.1 Each area on a street identified the map-based schedule as a parking place and, where applicable, by way of the map schedule legend as an area marked out and signed for the use therein of specified classes of vehicles following the conditions specified in the Order of 2021 in relation to that type of parking place, is designated as a parking place.
- 4.2 Unless otherwise so identified, a parking place shall be bounded on one side of its length by the edge of the carriageway and be an area marked either by a traffic sign or by another method of indicating the extent of a parking place as specified in the Traffic Signs Regulations and General Directions 2016°.
- 4.3 The provisions of the Order of 2021 (other than Articles 4 and 19) shall apply to the area designated as a parking place by this Order as if in those provisions any reference to a parking place included a reference to an area designated as a parking place by this Order.

Placing of traffic signs, etc

- 5.1 The Council shall:
 - (a) place and maintain traffic signs or other appropriate markings on the surface of the street indicating the limits of the parking place designated by this Order;
 - (b) place and maintain in or in the vicinity of each parking place, traffic signs indicating that such parking place may be used during the permitted hours for the leaving only of the vehicles specified in Articles 5.1, 5.2 and 5.5 of the Order of 2021; and
 - (c) carry out such other work as is reasonably required for the purpose of the satisfactory operation of a parking place.

4.1 Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the Order of 2021 shall have effect as though any waiting restriction identified in the map-based schedule and by way of the map schedule legend and marked out and signed as a waiting restriction shall be construed as through it were a restricted street referred to in the Order of 2021.

Revocation

5.1 Without prejudice to anything done or any liability incurred in respect of any act or omission before the coming into force of this Order the London Borough of Southwark (LSP Walworth) (Mapbased) (No. 2) Experimental Traffic Order 2021^c, and the London Borough of Southwark (Free parking places and waiting restrictions) (LSP Walworth) Experimental Traffic Order 2021^d, are hereby revoked.
